5. MISCELLANEOUS INFORMATION

SOACO has commissioned a set of professionals appointed by the Order of Accountants of Ragusa in order to proceed with an appraisal of the company, with the purpose to identify the value to be attributed to the eventual lease contract. The advice will be part of the tender documents.

The tender documentation will also include an occupational safeguard clause for personnel currently employed by SOACO.

This notice is intended as a mere process aimed exclusively at receiving expressions of interest from interested economic operators to facilitate participation and consultation of the largest number of them, in a non-binding way for the contracting authority, which does not assume any obligation regarding the continuation of the same, without the requesting parties having any claim.

The present expression of interest has the sole purpose of communicating to the Entity, the interest in stipulating the contract in question, therefore, with this notice no tender procedure is announced and there are no merit rankings or attributions of scores .

It is simply a cognitive survey aimed at identifying interested economic operators.

In any case, SOACO reserves the right to revoke this notice, not to proceed with the procedure, without the participating companies being able to claim any rights whatsoever and without any reimbursement for any expenses incurred.

If SOACO deems to proceed with the lease of the company, it will announce a public selection through an open call.
